YMCA Childcare Resource Service Referral and Complaint Policy

YMCA CRS provides free child care referrals to parents for their specific child care needs in licensed and legally license exempt facilities in San Diego County. Service is provided to all persons requesting them regardless of income or other eligibility factors. Confidentiality of both parents and providers is maintained. Child care referral lines are open Monday–Thursday from 8:00 am to 4:00 pm and Fridays from 8:00 am to 12:00 pm or referrals may be accessed online at www.crs.ymca.org.

Consumers are offered a variety of child care options including family child care homes, child care centers, preschools, before and after school care, and in-home agencies. YMCA CRS seeks to promote and develop quality care for children but does not make recommendations regarding particular providers. YMCA CRS strongly encourages parents to visit facilities and review provider histories with Community Care Licensing at 619-767-2200, prior to making the final decision for child care arrangements. Responsibility for selecting a child care provider rests with the parent or guardian.

YMCA CRS has established policies and procedures to ensure all complaints from parents, providers and the community are addressed in a clear and equitable manner. California legislation mandates that child care resource and referral agencies may not refer child care programs that are on probation, under a temporary suspension order or hold a revoked license from Community Care Licensing (CCL). Referrals are resumed when CCL sends written notification which indicates the program can return to active referral status. INCREASING AWARENESS

Reducing the risk of SIDS in your child care program

In 2008, **Sudden Infant Death Syndrome (SIDS)** was one of the top five leading causes of death in an infant (birth to one year) in California. San Diego County accounted for over 16 percent of SIDS deaths which was the second highest percentage according to the California Department of Public Health. Sadly, since 2008, the number of SIDS cases in San Diego County has increased.

SIDS is the sudden death of an infant (under one year of age) that remains unexplained after thorough investigation including autopsy and medical examination. Most deaths occur when a child is two to four months. SIDS is unpreventable and unpredictable, but research shows there are various factors that can be changed in your home or your child care program to lower the risk of a child dying from SIDS. Here is a list of the **Top 10 Recommendations for Safe Sleep** from the American Academy of Pediatrics.

1. **Back to sleep for every sleep**—To reduce the risk of SIDS, infants should be placed for sleep on their backs for every sleep by every caregiver until one year of age. Side sleeping is not safe and is not advised.
2. **Use a firm sleep surface**—A firm crib mattress, covered by a fitted sheet, is the recommended sleeping surface to reduce the risk of SIDS and suffocation.
3. **Room-sharing without bed sharing is recommended**—There is evidence that this arrangement decreases the risk of SIDS by as much as 50 percent. In addition, this arrangement is most likely to prevent suffocation, strangulation, and entrapment that might occur when the infant is sleeping in an adult bed.
4. **Keep soft objects and loose bedding out of the crib** to reduce the risk of SIDS, suffocation, entrapment, and strangulation.
5. **Pregnant women should receive regular prenatal care**—There is substantial evidence linking a lower risk of SIDS for infants whose mothers obtain regular prenatal care.
6. **Avoid smoke exposure during pregnancy and after birth**—Both maternal smoking during pregnancy and smoke in the infant's environment after birth are major risk factors for SIDS.
7. **Avoid alcohol and illicit drug use during pregnancy and after birth**—There is an increased risk of SIDS with prenatal and postnatal exposure to alcohol or illicit drug use.
8. **Breast feeding is recommended.**
9. **Consider offering a pacifier at nap time and bedtime**—Studies have reported a protective effect of pacifiers on the incidence of SIDS. The protective effect persists throughout the sleep period, even if the pacifier falls out of the infant's mouth.
10. **Avoid overheating**—Although studies have revealed an increased risk of SIDS related to overheating, the definition of overheating in these studies varied. Therefore, it is difficult to provide specific room temperature guidelines for avoiding overheating.

LEAD IN YOUR OLDER TURF?

"Childhood lead poisoning is an environmental health problem that causes adverse effects on children's development and later in adulthood. On average in San Diego County, there are approximately 114 cases per year (56 cases in the City) of lead poisoning in children" according to the City of San Diego Lead Safety and Healthy Homes program. Some older varieties of artificial turf (also called synthetic turf, synthetic lawn, or indoor/outdoor grass) were made with lead, a chemical that is well known for its potential to harm children's health. If children at your preschool, child care center, family child care home, playground, or school play on artificial turf, take advantage of the free turf screenings by the Center for Environmental Health (CEH). LEGISLATIVE UPDATE

Here are brief descriptions of some of the new bills that were signed in to law by Governor Brown. Legislation will take effect January 1, 2012. For the complete text of bills or to order copies, call 916-445-2323. If you have questions about a bill, contact the consultant.

SB 309 (Liu): School-age Child Care Centers: Non-minor Students.

Authorizes the California Department of Education (CDE) to approve or deny a written request from a school-age child care program to enroll or retain a non-minor (defined as 18 years of age or older with exceptional needs) in their program and specifies timing for that request. **Consultant: Andy Lane 916-651-4021.**

SB 429 (DeSaulnier): After School Education and Safety Programs: Supplemental Grants.

Provides flexibility to 21st Century and ASES programs with supplemental grants to serve students during the summer. Programs may change locations to address needs of pupils and school closures but must notify CDE of changes. Programs operating 6 hours per day must provide free or reduced meals for eligible pupils and establish an attendance and early release policy. Any new school that establishes an ASES or 21st Century program is eligible to receive a supplemental grant to operate during off-school times. **Consultant: Cynthia Alvarez 916-651-4007.**

SB 929 (Evans): Child Passenger Restraints

Requires a child that is younger than 8 years, unless the child is over 4 ft. 9 in., to be properly secured in an appropriate child restraint in the rear seat of a motor vehicle. Other vehicle restraint provisions are included. Note: This bill removed the 6 years/60 lbs. requirement and replaces it with the 8 years/4 ft. 9 in. requirement.) **Consultant: Margie Estrada 916-651-4002**

SB 299 (Evans): Employment: Pregnancy or Child Birth Leave

Ensures that employer-provided health insurance coverage is continued for women on pregnancy disability leave. Amendments would make it unlawful for an employer to refuse to provide reasonable accommodation for an employee for conditions related to pregnancy, childbirth or a related medical condition, if she so requests, with the advice of her health care providers. An employer must maintain and pay for coverage under a group health plan during approved leave time and may recover the cost of the group health plan under specified circumstances. **Consultant: Bobby Sardo 916-651-4002.**

AB 2084 (Brownley): Child Day Care Facilities: Nutrition.

Requires a licensed child day care facility to follow specified guidelines relating to the provision of beverages (milk, juice and water). Includes the exclusion of a child, with documentation from a physician, from any of the requirements (e.g., 1% milk or nonfat milk, no beverages with added sweetener) if the child's health would be adversely affected.

NEW BEVERAGE GUIDELINES FROM COMMUNITY CARE LICENSING

Beginning January 1, 2012, new legislation, AB 2084 (Brownley) Child Day Care Facilities: Nutrition, will go into effect requiring all licensed child care facilities to provide the healthiest beverage options possible. Community Care Licensing will be looking for compliance with the new beverage guidelines on their licensing visits.

The new guidelines require that **whenever milk is served, only low fat (1%) milk or nonfat milk is served to children 2 years or older and no more than one serving (4 oz) of 100% juice is served each day.** Beverages with added sweeteners are not allowed to be served and drinking water must be readily available and accessible for consumption throughout the day. A great way to ensure water is readily available and accessible is to have a child sized pitcher of water and cups sitting out in the classroom and outside as well as on the table during meals and snack. This will encourage children to have water when they are thirsty and help them develop healthy drinking habits.



LICENSING UPDATE

INSURANCE SCAMS TARGETING LICENSED CHILD CARE PROGRAMS

FRAUD ALERT: Child Care Providers should be aware of another scam in California targeting licensed child care programs. Individuals claiming they represent insurance businesses in California are contacting child care providers regarding insurance. Individuals give the provider the impression they have connections with the Community Care Licensing Division (CCLD) and that due to the licensee's compliant licensing record, they are eligible for health insurance. CCLD does not endorse insurance organizations for child care providers (liability, health or other). If you are contacted by anyone claiming to be associated with CCLD and trying to sell you insurance, call 619-767-2200.





LITERACY ACTIVITY: POLAR BEAR, POLAR BEAR, WHAT DO YOU HEAR?

Materials Needed:

- Book - Polar Bear, Polar Bear, What Do You Hear? By Bill Martin and Eric Carle

Before reading *Polar Bear, Polar Bear, What Do You Hear?*, ask the children what they think the story will be about. After reading, ask the children to tell you what has happened in the story. Talk about some of the words in the story such as "bellowing," "yelping," and "trumpeting." Explain that these are all words that mean a loud kind of noise. Ask the children, "What other noisy words can you find in this book?"

PARACHUTE POPCORN

Place several foam or whiffle balls on a parachute and have the children stand around the parachute holding onto the edges. Have the children shake the parachute vigorously to "pop" all of the balls out.

RETRIEVE THE BALL

Place several colored balls on the ground under the parachute. While standing around the edge of the parachute, have the children shake the parachute up and down while calling on a child to go under and retrieve a certain colored ball. As the child comes out from underneath the parachute call on another child until all of the balls have been retrieved.



ST. PATRICK'S DAY PLAY DOUGH

Materials Needed:

- 1 cup flour
- ½ cup salt
- 2 tsp cream of tartar
- 1 cup water
- 1 tbsp oil
- Green food coloring or kool-aid
- Medium size saucepan

Combine flour, salt and cream of tartar in a saucepan. In a separate bowl mix the water, oil and food coloring. Gradually stir the liquid ingredients into the flour mixture. When the mixture is smooth, cook over medium heat, and stir constantly until a ball forms. Remove mixture from heat and knead until smooth. Keep play dough in plastic bags when not in use to prevent drying.
